



## INSTRUCTIONS FOR ELECTRONIC FUNDS TRANSFER (EFT) ENROLLMENT FORM

Dear Interest Owner,

Blackbeard Operating, LLC is pleased to provide the option of Electronic Funds Transfer (EFT or sometimes referred to as ACH) to its revenue interest owners. This optional service is being offered for your convenience and is at no additional cost to you.

Blackbeard has the following requirements to successfully enroll in Direct Deposit:

- EFT payments are only available for accounts drawn within the United States.
- For your protection, we require an original, voided check printed by your bank or your bank's authorized printer that includes the bank name or logo. We are unable to accept copies of checks, checks not printed by your bank or their authorized printer, temporary checks, deposit slips, or bank letters.
- We are unable to directly deposit to a savings account.
- The bank account name must match exactly with the name on file with Blackbeard. E.g. if there are multiple names on the Blackbeard account, all names must be listed on the bank account.
- If you are sending information for a Trust, the bank account name must match the trust name. We are unable to transfer funds electronically to a Trustee's personal account.
- The Electronic Funds Transfer (EFT) Enrollment Form must be filled out in its entirety including the last three payments issued by Blackbeard if applicable. If you do not have the information available, you can create an account through [www.energylink.com](http://www.energylink.com) to access the information. If a payment has not been made to you by Blackbeard, please note this on the form.
